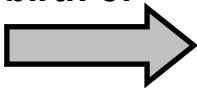

Gary was born and raised in Ipswich, Massachusetts. In 1968, Gary left Ipswich and was off to Navy boot camp at Great Lakes, in the lovely city of Chicago. Upon graduation from boot camp, Gary attended training as an Electronics Technician (ET) (or better known as an extra-terrestrial). After completing his training as an ET, he continued on to Fort Monmouth, NJ, for advanced training in Electronics. He served in the Atlantic Fleet in broadcasting and transmitters and receivers repairs. Returning to Fort Monmouth after a tour in Scotland, he again attended school, this time for satellite communication operations and repairs. During his time in the Navy, from 1968 to 1977, Gary served tours in Scotland, Ethiopia and Hawaii. “outstanding support in space flight safety and mission success”.

Also, during his time at MSFC, Gary was awarded the Distinguished Public Service Medal for “outstanding technical leadership in the HOSC Shuttle

Engineering Support Center”. After visiting and vacationing in this area for over 30 years, Gary and his wife, Charlotte, came to retire in Clay County (Shooting Creek, Eagle Fork). The American Legion Junior Shooting Sports Program is a gun safety education and marksmanship program that encompasses the basic elements of safety, education, enjoyment and competition. Shooters use the .177 caliber air rifle. Both males and females can participate, through Legion sponsorship; disabled youth are encouraged to join, as competitive shooting is a sport that creates an equal playing field for all competitors.

Air Rifle Competition

The annual 3-Position Junior Air Rifle National Championship is a tournament that begins with postal matches. State and/or regional champions are determined and advance to a qualification round (also a postal match) to determine the athletes who will earn expense-paid trips to compete in the national championship. The national championship is a shoulder-to-shoulder match held each July at the USA Shooting range facilities at the Olympic Training Center in Colorado Springs.

District Report

Jack Greve

This is a report concerning the subject meeting hosted by Brevard, Post 88 with a meal provided at 12 noon and the formal meeting at 1 PM on December 10, 2022. The meeting was called to order with prayer by District Commander Shannahan. Roll call of the posts in the district was taken and the following are the results:

Waynesville Post 47 - Absent

The only Officer in attendance from our post was Jack Greve. No other Officers or post members volunteered to attend or were otherwise committed elsewhere. This does not show well for our post. A total of approximately 18 Legion members from District 25 were in attendance which made a quorum.

CMDR Shannahan then recognized present and past

officers in attendance. Each post present was then given the opportunity to give a short dissertation of their post activities. The report given by Judge Advocate Greve for our post is provided at the end of this memo for your information. There being no further new or old business, CMDR Shannahan called for discussion items under 'Good of the Legion'. Other items discussed during the meeting were directed to the membership drive, attendance at various Department functions, various drives conducted by the Department, upcoming Legion College, and the need by posts to participate in the various awards offered by the Department and National Headquarters.

Division Commander Jim McGill then took the floor. He commended Post 370 Highlands for reaching 100% in membership and encouraged the other posts to continue their drive to reach their goals. He then commented the concern at the Department regarding posts completing their annual 990's to the IRS and the lack of EIN numbers. At present out of all posts in the State 40 have not filled their 990's and are lacking

EIN numbers. The present status of these posts is they have been placed on temporary SUSPENSION until these problems are resolved. This means they can only function in the capacity of collecting dues, filing back taxes and filing for an EIN number. No other activities by these posts are allowed until these problems are resolved.

Jim then reminded everyone of the upcoming increase in dues of \$5.00 per member beginning on January 1, 2023 stating that this is the first increase by the Department in 23 years.

Other information provided by CMDR McGill is unknown at this time as I requested to be excused

(approximately 1:14 PM) due to a physical health issue. To the best of my knowledge the meeting was

adjourned around 2:15 PM.

provided to the District Commander as required.

CONSTITUTION & BY-LAW CHANGES

FOR POST 532

In order to bring our present document up to date the following additions and changes have been approved by our Post Executive Committee and are in accordance with our Constitution and By-Laws and the required procedures as set forth by our Department. If you have any questions or concerns, please contact the following individuals within the next 30 days.

CONSTITUTION CHANGES: Article V – Officers

Section 1. The administrative affairs of this Post of the American Legion Shall, except as may be otherwise provided by the By-Laws, be under the supervision of an Executive Committee which shall consist of all Post Officers, plus three additional Executive Committee members at large. - - - - -

BY-LAWS CHANGES

Article I

Section 2. The Executive Committee shall consist of all officers of the post plus three additional Executive Committeemen. - - - - - All elected officers and the at large executive committeemen (3) shall be by ballot, show of hands, or acclimation - - - - -

Article III --- Post Executive Committee

Section 4. The Executive Committee shall authorize all other designated accounts for the purpose of transacting Post business. The chairperson of each program shall maintain their checkbook for their specific program/account. Each program shall chair shall provide monthly expense and income totals to the Post Finance Officer. Each



A Veteran's Life

It was quite the eye opener. My son was deployed to Afghanistan, we went to see him off and were there when he returned. I was in the military when Desert Storm began, but I was never deployed to an area of action. This was not the case for my son. He came home changed in many ways. Like many combat veterans, he did not want to talk about it.

After some months, he called and told us he had just gotten out of the hospital. Shocked, we asked why. He said, "My roommates came in my room and found me with my gun to my head." Shocked was no longer how we felt; we were heartbroken. It comes as no shock to me to hear that 22 veterans a day commit suicide, and half of them are women. Since my son was young, he carried on about how he was getting old and falling apart. When he started telling

me things wrong with him, I didn't really pay attention. Now, he is medically retired. He came home for Christmas, and things he had told me were more evident. The trouble with the knees could be seen, and there was the hearing aid. Soldiers are supposed to wear hearing protection when riding in helicopters, but medics have to be able to communicate, so he didn't, and his hearing paid the price. While he didn't pay the ultimate price for our freedom, I feel honored to call him my son. I am humbled by his protecting my freedom.

All of our veterans need support in a wide range of areas from a wide range of people. As a nation, we need to continue to support each of these men and women. We need to pressure congress to ensure they are cared for. Are you wondering what you as an individual can

do? Here are a few suggestions. Thank a veteran every chance you get. Show your support by attending patriotic events. It is sad when a town can't get but a handful of people to show up for Memorial Day, MIA day, and Veteran's day. If you're a veteran, make sure you join other veterans in groups like the American Legion.

So, what about my son? He was blessed to be able to get mental help and is doing well. I'm not ashamed of his actions. I don't love him less. Scars, especially mental or emotional scars, take a long time to heal and some never heal at all. When you lay your head down on your pillow tonight in the freedom of your own home in the land of the free, take a moment to say a little prayer for the men and women who have provided your freedom and have paid a price to do so.

If only it was the end of my story. This was not the only

realization of what others are going thru. My son and I were visiting his brother, also a veteran, this Christmas. We dropped off gifts and gave quick hugs because his wife and children were sick. As we drove back home and were about an hour and half from the second son's home his wife called me. They had a fight, he left and sent a text that he was going to kill himself. I immediately turned around. He had said he was going to his grandparents farm, where his veteran brother was buried. The police were called but no one had seen him. By the time I returned to town he still was not found. Led by God I decided to check the boat ramp a mile from the farm. I found him. He was drunk, but alive. The plan was to drive into the creek and drown. I found out he had tried the night before, but the gun wasn't loaded.


We must be vigilant to help our fellow veterans. Don't be afraid to seek help, it is available.

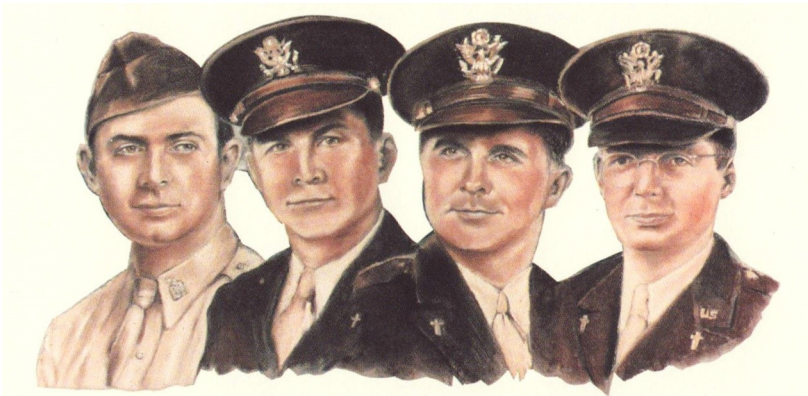

BE VIGILANT OF PACT ACT SCAMS

On August 10, President Biden signed the Sergeant First Class Heath Robinson Honoring our Promise to Address Comprehensive Toxics Act (PACT Act) into law. This law helps millions of Veterans and their survivors by:

- Extending VA health care eligibility for Veterans with toxic exposures and Veterans of the Vietnam, Gulf War, and Post-9/11 (Post-September 11, 2001) eras
- Expanding benefits eligibility for Veterans exposed to toxic substances and their survivors



Tips to Avoid PACT Act Scams

Scammers are taking advantage of new opportunities to commit fraud. There's been an increase in PACT Act-related [phishing \(email\)](#), vishing (phone), and [social media scams](#) targeting Veterans to access their PACT Act benefits or submit claims on their behalf.

Veterans should be cautious of anyone who guarantees a lucrative financial benefit or service.

Do's

- ✓ You may submit your application securely [online](#) via VA.GOV or in person at any Regional Office. You may file your claim directly with VA and then, VA will assist in gathering evidence necessary to support it. There are no costs or hidden fees to apply.
- ✓ Be cautious of companies who advertise VA benefits can only be obtained with their help. These companies may not be recognized by VA and may be attempting to charge illegal fees.
- ✓ Be cautious of aggressive companies who may try to pressure you to sign their contract through frequent communications or by insisting "you must act now or lose your chance for benefits."
- ✓ Be cautious of companies who claim to be contacting you on behalf of VA or to have a special relationship with VA. Contact VA at 1-800-827-1000 if you are unsure about the authenticity of any message received.
- ✓ Validate: If you are interested in working with a Veteran Service Organization (VSO), agent, or attorney, use the Office of General Counsel [Accreditation tool](#) to confirm and validate their credentials.

Don'ts

- ✗ Do not sign a contract agreeing to pay an unauthorized company a percentage of your benefit payment in exchange for their assistance with your VA claim. If you need help filing a claim, there are representatives of VSOs, agents, and attorneys who have been [accredited by VA](#) to assist you.
- ✗ Do not sign a blank form for someone else to complete later. Always review the completed form before signing and keep a copy for yourself.
- ✗ Do not be fooled by companies who advertise they have special relationships with medical professionals and can guarantee your benefits award. If they are defrauding the Federal government, you could be held responsible for paying those benefits back.
- ✗ Do not provide your social security number, medical records, or other personally identifiable information to anyone offering claims assistance before confirming their credentials using the Office of General Counsel [Accreditation tool](#).
- ✗ Do not sign forms that are not [VA generated](#) or third-party authorization for someone to provide "behind-the-scenes" claims assistance.
